**RESOLUTION**

**“THAT this Board confirm the appointment(s) of Roxanne Head effective January 1<sup>st</sup>, 2011 and Corey McGee, effective January 2<sup>nd</sup>, 2011 for the position of 4<sup>th</sup> Class Police Constables for the Belleville Police Service.**

**Background:**

On December 8<sup>th</sup>, 2010 conditional offers of employment were made to Roxanne Head and Corey McGee for the position of 4<sup>th</sup> class police constables.

The offers of employment were conditional on the understanding that they successfully complete a medical examination by our police service physician and successful completion of the Basic Recruit Training Course at the Ontario Police College.

Both candidates have strong ties to the community and have met the pre-requisites under the Constable Selection Program.

I respectfully request that the Police Services Board approve the conditional offer of employment and their appointments to the Belleville Police Service effective January 1st (Head) and January 2nd (McGee) 2011, respectively.


These two appointments will fill two vacancies and do not increase the authorized strength.

Roxanne Head has been a Community Policing Volunteer since 2007, an active Auxiliary Member and a Part-time Special Constable since March 2010. In 2005 Roxanne enrolled in the Loyalist College Police Foundations and graduated in 2007 on the Dean's list. Roxanne received many certificates of recognition for her achievements and contributions to the community. She is an active volunteer with Victim Services in addition to her volunteer commitment at the Belleville Police Service. Roxanne is very pleased to be offered a position as a police constable with our organization.

Corey McGee attended St. Paul's Secondary School in Trenton and while at Loyalist College, received the Hugh and Donna O'Neil Award for academic excellence. Corey graduated from Laurentian University with a B.A. in Physical and Health Education, was awarded a Citation of Merit for providing leadership and a meaningful contribution to the community, was a member of Student Council as well as Residence Supervisor. Corey volunteers at the YMCA in Quinte West and holds a management position with McDonald's Canada in Trenton.

Roxanne and Corey will be attending Basic Constable Training January 6<sup>th</sup>, 2011 to March 31, 2011.

1. **CALL TO ORDER**

The meeting was called to order by Chair, Robert Dolan at 6:03 p.m.

2. **DECLARATION OF INTERESTS**

3. **DEPUTATIONS, PRESENTATIONS OR APPOINTMENTS**

(a) **Zone Policing/Differential Response/Website (Senior Staff)** Verbal  
 Chief McMullan introduced her members of Senior Staff to the Board. She explained that the members of Senior Staff will be presenting details of these three initiatives - Zone Policing/Differential Response/Website. Deputy VandeGraaf acknowledged the contribution of all to the development of the new website.

**Zone Policing**

Inspector Gray provided background information related to the development of the Zone Policing. Using a large coloured map she explained the demographics of each zone. Deputy VandeGraaf provided statistics which were mapped to the various zones indicating the types of crimes. This tool is very helpful in analyzing crime and optimize community police service.

**Differential Response**

Deputy VandeGraaf explained differential response which is a strategy that allows the service to optimize staffing and response times. This is a way to provide non-emergency service without responding in person and allows officers to respond quickly to emergencies.

**Website**

Deputy VandeGraaf explained that revitalizing the website was part of the communication plan in the most recent business plan. He stated that he feels the new website is the best vehicle to communicate with the community. Deputy VandeGraaf walked the group through each section of the new site.

He explained that an RSS feed has been added which allows people to sign up for updates. An online reporting feature has been added to the site and Deputy VandeGraaf explained how to utilize the site and under which circumstances the feature would be used.

The crime map page of the website was presented to the Board. Deputy VandeGraaf explained that this map will allow the public and media to search and see what has been taking place in their neighbourhood. Online criminal record checks will be available online soon. It is hoped that this feature will be ready to go by mid December of this year.

The service has made a commitment to have platoons remain consistent for a period of two years so that officers will be working for a period of time in the same community.

Chief McMullan stated that there will be future media releases detailing new features as they become available on the site. She thanked members of senior staff for their many hours of work on this project.

Vice Chair Wagner congratulated the service on their excellent work. She stated that it's nice to see that many of the suggestions made by members of the service have been implemented.

Chief McMullan stated that this is a new initiative to provide examples of times where officers have gone above and beyond. She provided an overview of an October 8<sup>th</sup> break and enter where the investigation and quick response time of Constable Mark Harry and Constable Laura Empey lead to the arrest of a 15 year old male. Chief also recognized the commitment and professionalism displayed by members of the service in preparing and executing the court security plan to provide security for the high profile and risk William's trial. She stated that court security went off without a hitch. Many emails and letters have been received commending staff for their work throughout the court case.

To Whom it May Concern:

The Bail Notification Program was established as a grant initiative in April 2009 delivered by Victim Services of Hastings, Prince Edward, Lennox & Addington Counties. The goal of the program is to meet the needs of victims and enhance identification/monitoring of high risk offenders in the Hastings court jurisdiction. Victims of violent crime, including domestic violence, assault, sexual assault, robbery, home invasion, amongst others, have a number of needs relating to their safety. Many of which can be addressed through community supports, in an immediate fashion through the Bail Program.

Since 2000, Hastings County entered into a protocol with the Ministry of the Attorney General – Crown Attorney's Office, which indicates the investigating police service is responsible for notifying victims when the accused has been released or detained, as well as terms or conditions or variations of that release. This applies to the four police services attached to the court; Belleville Police Service, Quinte West OPP, Central Hastings OPP and Bancroft OPP.

The Victim Services program objective is to continue to provide service to bail court victims as ensuring that over 461 victims were notified during the 18 month grant process; which required 1168 phone calls made through this program; engaging with victims after business office hours; and increasing our referrals to community agencies & therefore enhancing victims safety; thereby decreasing the risk that victims fall through the cracks and are un-served.

With one central contact person all victims in every municipality will receive a consistent coordinated service, at a substantial cost savings to the taxpayer. The municipalities will have their police services budget decreased due to court officer's not working overtime in order to notify victims of bail conditions. The silo's that currently exist within the municipalities will be eliminated with cost sharing of one employee, employed by Victim Services. The safety of every victim will be paramount and the Victim Services organization is the natural choice to ensure that victims receive all resources available to them in their local communities.

We believe that this program is vital to our community's health and safety. The total cost for service of Bail Program is \$62,470.00. Of this amount, the service fee that has been allocated per municipality is based on the percentage of victims served in a 12 month period. Your investment will complete the funding necessary for the 2011-2012 fiscal years. Please see attached for budget.

Thank you for your letter dated October 29, 2010, regarding a proposal to modify the eligibility criteria for the Peace Officer Exemplary Service Medal (POESM)

Since its creation in 2004, the objective of this medal has been to recognize those individuals employed by federal and provincial organizations who serve as peace officers in high-risk professions. Eligibility is approved by the Advisory Committee of the POESM, which is chaired by the Canada Borders Services Agency and includes representatives from provincial governments. The daily element of risk is a primary consideration in eligibility.

Please rest assured that the matter will be brought to the attention of the Advisory Committee of the POESM as well as the Canadian Honours Policy Committee. I will be in touch with you again as soon as a decision has been taken.

Your views about expanding the eligibility criteria of the POESM are important to us and we have added your letter to our files. Thank you for writing.

**Background:**


On December 14th, 2010 at 7:45 a.m., police attended at a business on Bridge Street West in response to a robbery complaint. Police learned that a male entered the business brandishing a weapon and demanding money from the lone employee. The male then left the business on foot. Investigation led to information that the male was in a taxi that was travelling into Belleville. This vehicle was stopped and a 28 year old male of Belleville was arrested and has been charged with Robbery, Wearing a Disguise with Intent to commit an Indictable Offence, Carry a Concealed Weapon, Possession of a Controlled Substance and Fail to comply with an Undertaking. This case is still before the Courts.

The successful apprehension of this individual was an excellent example of collaboration and teamwork amongst the members of D Platoon, supervised by S/Sgt. Chris Barry. The initial call received by Communicator Penny Neal-Creelman, who obtained the detailed information and relayed that to the responding officers, Patrol Sgt. Sheri Meeks, who co-ordinated the efforts of the responding officers and the responding officers; Cst. Dan Hounslow, Cst. Dave Bradley, Cst. Rene Aubertin, Cst. Mike Kiley, Cst. Tony McCambridge, Cst. Daryl Erwin and Cst. Aaron Bucci. Each officer had an intricate role with this incident and investigation. It should be noted that Cst. Lindsay Stephenson was covering other calls for service in order for her fellow Platoon members to concentrate on the apprehension/investigation of this individual.

Detective Constable Monique Waite is to be commended for her efforts in investigating the recent spate of thefts and robberies in the Belleville and Quinte Area. Detective Constable Waite worked extremely hard in comparing similarities between numerous incidents and was successful in linking occurrences and suspects. She was also able to link these incidents with similar ones in the OPP area and as a result became a valuable resource to the OPP who made numerous arrests in their jurisdictions.

AS a result of Detective Constable Waits efforts, and that of the Belleville Police Service and OPP investigators, arrests have been made and charges laid in relation to a robbery on the 29<sup>th</sup> of August 2010 at 1627hrs in a Drug Store on Bridge St E. and two thefts from a restaurant on Dundas Street East. These cases are still before the courts.

**Subject: OIPRD Decision**

**Recommendation: Review and file for information**

**Background:**

The Belleville Police Service responded to a report of a disturbance at a west end Belleville address on November 28, 2009 at 8:06pm. As a result of this call a male was arrested and charged. Based on what Chief McMullan knew at the time, the use of force options including the conducted energy device were utilized, according to Service procedure and as a direct result of the male's behaviour, however unfortunate that may have been. The case has been completed in the courts by way of a peace bond.

The case received extensive media coverage prior to completion in court and Police were restricted from releasing further information. Freedom of Information legislation also severely restricted the Police Service's ability to respond to the media's coverage of this incident. The male was not restricted from speaking to the media. At the time Chief McMullan advised that the victim and police version of the events was substantially different from the male who made the complaint against police.

The male filed a complaint against the Belleville Police Service. Chief McMullan had an investigation completed. The complainant then filed an appeal of the Chief's decision with OIPRD.

On December 20<sup>th</sup>, 2010 the Office of the Independent Police Review Director advised that upon review, the Panel was overall satisfied with the investigation conducted into this matter. Therefore, the OIPRD has confirmed the decision of the Belleville Police Service disposing of this complaint under section 66(2) of the Police Services Act as being unsubstantiated. The respondent officer has been advised of the outcome and OIPRD has closed the file.
